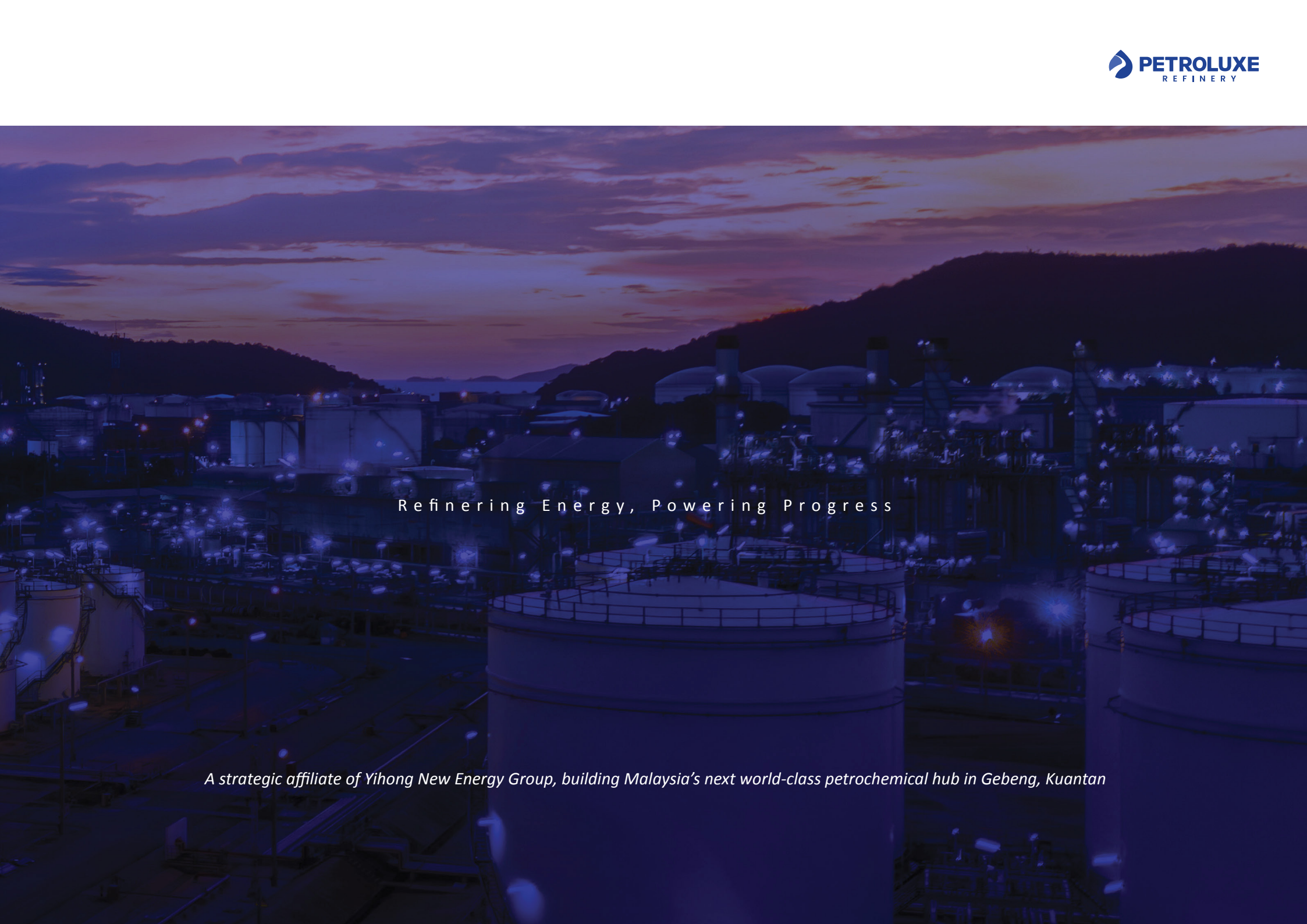

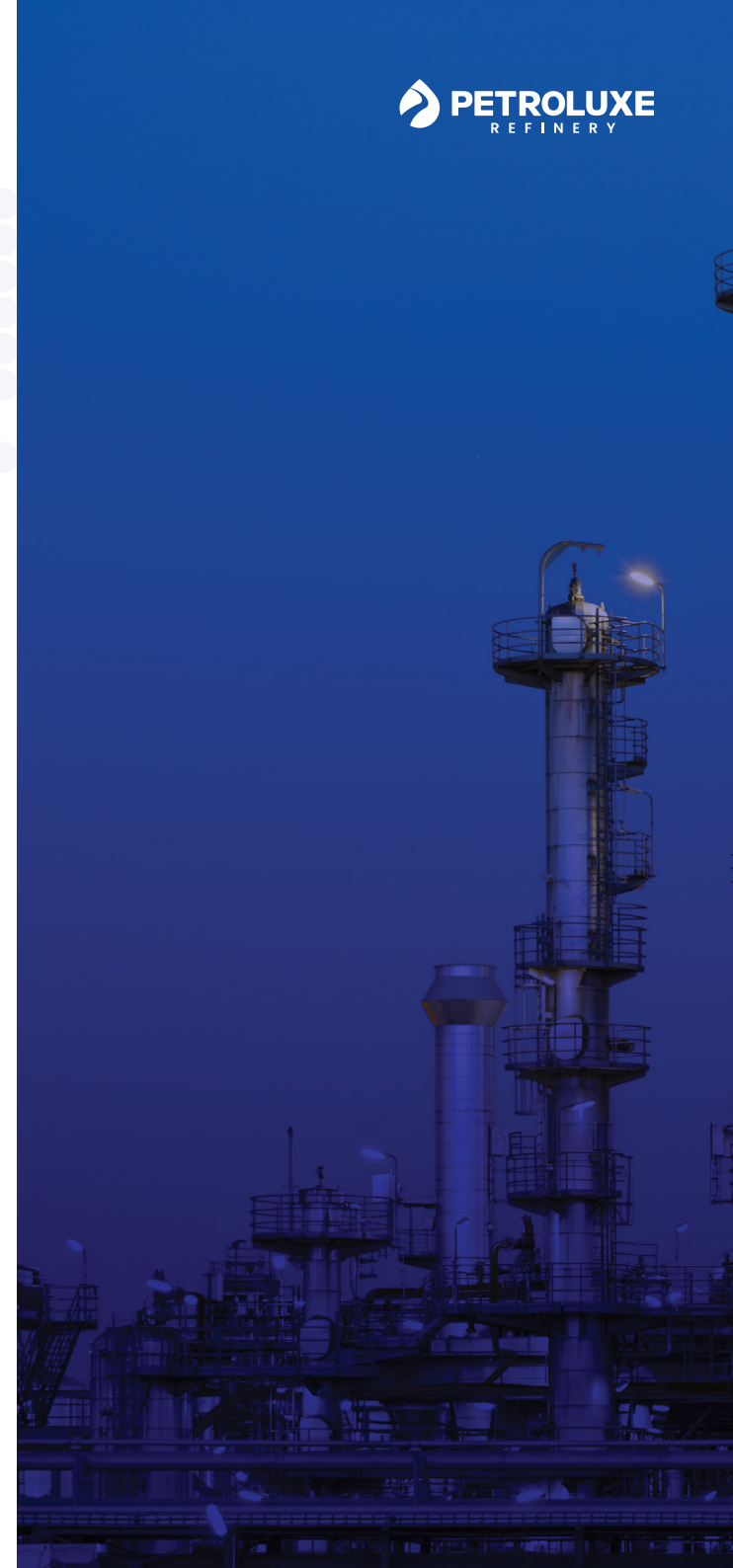

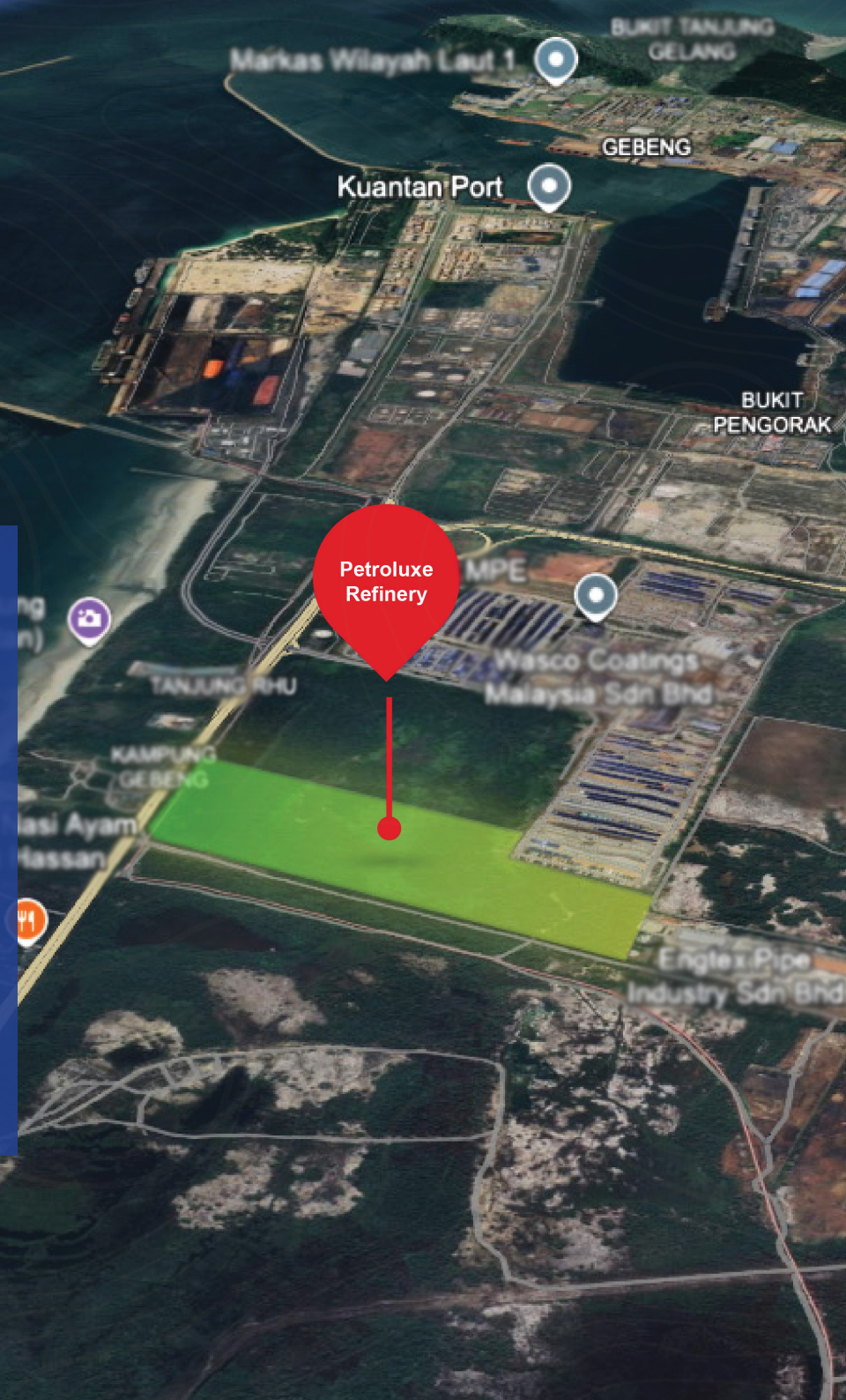
STRATEGIC PURPOSE & EXPANSION PLAN

- Post-2027: Expansion into specialty chemicals and advanced petrochemical products

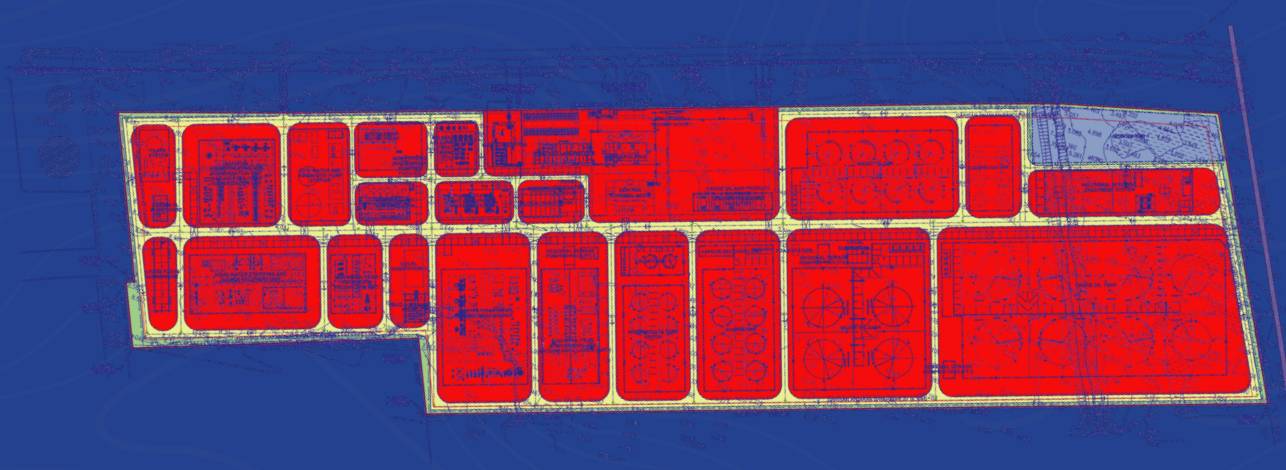


Site Layout & Facilities Description

Location : PT 28711, Mukim Sungai Karang, Kuantan, within the Gebeng Industrial Area a prime industrial hub with close access to Kuantan Port and the South China Sea.

Key Facilities:

- **Storage Tanks:** Crude Oil, Heavy Oil, Blending, Intermediate, Product Oil, LPG Tanks.
- **Processing Units:** Atmospheric & Vacuum Distillation (1.2M TPA), Diesel Hydrotreating, Hydrogen Production, Naphtha Hydrotreating & Isomerization Units.
- **Utilities:** Power Station, City Water & Firewater Pump Station, Foam Station, Air Separation, Nitrogen Station, Vapour Recovery Unit, Effluent Treatment System.
- **Support Buildings:** Central Control Room, Analysis Laboratory, Warehouses, Office, Guard Houses, Maintenance Workshop.

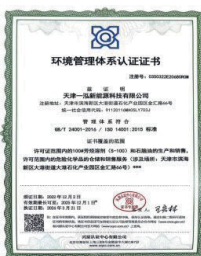
